

Dear 2016 Frontiers Attendee:

Thank you for registering for Pharmacotherapy Frontiers, 2016. We are looking forward to an excellent program this Saturday, April 16th at the National Institutes of Health Clinical Center Masur Auditorium.

Please be sure to print these out and bring them with you, as hard copies will not be available at the program. The Masur Auditorium offers complimentary WiFi (NIH-Airnet-Guest), so these documents may be accessed online during the program as well. Coffee will be available during registration and there will be light refreshments served at the halfway point of the program. The seminar is filled to capacity this year, so please leave enough time to go through security and find parking (approximately 30-45 minutes).

No CE certificates will be mailed to you. You will be able to print the certificates yourself after completing an on-line evaluation. Attendees have through **May 16th (one month)** to complete the evaluation and thereby be eligible to receive CE. Due to increased security measures please:

- 1. Allow 30 to 45 minutes for security check.**
- 2. Bring a government-issued picture identification such as a driver's license or military ID. HHS employees should bring their HHS ID card to expedite entrance to the campus similar to an NIH employee.**
- 3. Follow the campus entry instructions below based on whether you are a "General" or an "HHS" attendee.**
- 4. Wear visitors pass at all times during seminar.**

Note: Although exercise is strongly encourage, we recommend that attendees drive or carpool to the seminar as campus access from the Metro station requires walking a considerable distance to the security station and then to the seminar.

IMPORTANT: NIH Campus Access for Pharmacotherapy Frontiers 2016

Non- HHS employees MUST use the following access point to the NIH Campus.

General Attendees By Automobile

- You MUST use the Commercial Vehicle Inspection Facility (CVIF). The CVIF entrance can be accessed from Rockville Pike heading SOUTH from the intersection of Rt 355 and West Cedar Lane. Your vehicle will be inspected and drivers and passengers will go through the magnetometers. Any luggage, handbags, or briefcases will be screened through X-Ray machines. Please have your government-issued (i.e. driver's license, military ID, passport, etc.) identification readily available to be checked against the attendance list. Follow posted signs to the NIH Clinical Center (Building 10).**

By MetroRail or Other Public Transportation

- The NIH campus shuttle does not run on the weekends. The Gateway Center is also closed on the weekends, therefore, **participants who elect to metro to the event must walk to the CVIF for campus entry and then walk to the Clinical Center.**

Participants are strongly encouraged to drive or be dropped off at the CVIF.

HHS EMPLOYEES

- HHS ID Cards (**NOT** Uniformed Services ID card) will be honored at vehicular employee gates. Persons holding an HHS ID card will be admitted in the same manner as an NIH employee, although you must show your ID to the guard and the gate will be lifted remotely. All automobile occupants using the employee entrances must have the HHS ID card. Others must use guest entrance (CVIF).
- HHS employees with ID cards may use the entrances at South Drive and Rt. 355 (Metro) or Old Georgetown Road at Center Drive.

PARKING

Visitors and employees may park in any general NIH permit holder parking space. There is no charge for metered or garage parking on Saturday. The outdoor parking lot at the South entrance of the Clinical Center (lot 10H) is the most convenient parking lot for the seminar. It appears as a grey rectangle on the campus map available at www.nih.gov. Underground parking (P1 garage) is available on the west side of Building 10, but subject to another security checkpoint and could cause a major delay for you. Handicapped parking is available in the parking garage. Please review the campus map, or visit www.nih.gov and select “Visitor Information”.

All attendees may exit via South Drive and Rt. 355 (Metro) or Center Drive to Old Georgetown Road.

Sign-in begins at 07:30.
