1. Report from the American Society of Health-System Pharmacists (ASHP) Midyear Clinical Meeting, 2016: Attendance and Presentation

WMSHP President Dr. Vaiyapuri Subramaniam recently attended and presented at the American Society of Health-System Pharmacists Midyear Clinical Meeting (ASHP MCM) that was held in Las Vegas, Nevada, USA, from December 4 – 8, 2016. The ASHP MCM is the largest gathering of pharmacists and the longest-held clinical meeting in the world. The ASHP MCM in Las Vegas drew an estimated 25,000 attendees with a target audience directed for pharmacists, pharmacy residents, students, nurses, physicians, administrators, consultants, health-information technology professionals, medication safety officers and policy makers. With the wide variety of topics presented, the 2016 ASHP MCM provided attendees opportunities to attend sessions that included but not limited to pharmacotherapeutics, pharmaceutical sterile compounding and hazardous drug management that focused on United States Pharmacopeia (USP) Chapters 797 and 800 standards, informatics, pharmacogenomics, antimicrobial stewardship, public health, biosimilars and opioid therapy and substance abuse disorders. As part of the 2016 ASHP MCM, Dr. Subramaniam and his co-presenters (Brenda Jensen, MBA, CNMT, CPhT and Mary Li, PharmD) were invited to

present a Management Case Study educational session on **“Evaluation of Pharmacy Workplace Safety Training Program to Ensure Regulatory Compliance.”**

The presentation focused and incorporated three key approaches, viz. 1) the identification of US federal agencies that regulate workplace safety and the main components of the US Occupational Safety and Health Administration (OSHA) hazardous communication standard; 2) an explanation and listing of key facts about the United Nations Globally Harmonized System (GHS) of Classification and Labelling of Chemicals that was implemented in June 1, 2016; and 3) the identification of common deficiencies in pharmacy workplace safety training programs. With heightened awareness on the compounding of pharmaceutical sterile and hazardous drug preparations required to meet USP <800> standards, the presentation identified additional requirements for continued compliance and provided a gap analysis from results to current standards and regulations so that training deficiencies could be identified. The presentation included the OSHA hazardous Communication Standard and its alignment with the United Nations GHS

to ensure consistency in how hazards are classified and how hazardous chemicals are labeled, e.g. by way of pictograms that are required on labels to alert handlers of hazardous chemicals as one tool for employers meet compliance. It becomes important that pharmacy leadership review relevant standards and regulations related to pharmacy workplace safety training annually and make revisions to ensure continued compliance.


WMSHP Meeting With Howard University College of Pharmacy (HUCOP) new Dean:

As a USP Convention Organizational Delegate, Dr. Subramaniam will represent the VA to the USP and support and identify areas and programs where both organizations can collaborate or share a common purpose or interest, such as quality product standards, (medicines, dietary supplements and foods), practice standards, patient safety, and global public health initiatives. In the VA, Dr. Subramaniam serves as Associate Chief Consultant in the Pharmacy Benefits Management Services, Veterans Health Administration, Washington, DC.
